Send the completed form along with the fee of \$5.00 per image to the jury coordinator before the entry deadline. Include a SASE if you want your receipt or jury results mailed to you, otherwise the receipt only will be available for pickup at the show.</p> <p>Submit the digital images to the jury coordinator via email. Send one email per image with your name, show name and the number of emails in the Subject line. Follow the Digital Jury Submission Guidelines for image specifications.</p> <p>Incomplete forms, poor quality images and late delivery may result in your entry not being submitted for jury. It is your responsibility to ensure everything is submitted per the guidelines.</p> <p>Only Qualifying (previously known as Juror's choice) and NON Qualifying (Chapter's choice) will be accepted in the show. Once the jury results have been compiled, a list of the accepted paintings will be emailed to the participating artists. Only members who don't have access to email will be contacted by mail or phone. Do NOT contact the jury coordinator for results</p>
